Louvrette's manufacturing facilities covering 8,500m² are an important contribution to the already existing production plants of Quadpack in Spain, positioning the company under the top 10 suppliers of beauty packaging in Europe.

The most recent growth activities are part of the company's strategic growth plan which enabled the company to double turnover over the past four years. Thanks to this latest transaction in line with this strategy, Quadpack succeeded in making the company one of the market leaders in the global beauty sector.
